#### Bequest

Designate Indian River Lakes Conservancy as the recipient of cash, real estate, or another asset in your will. Or you can leave a percentage of your overall estate to IRLC.

#### **Retirement Plan Assets**

Name Indian River Lakes Conservancy as the beneficiary of an IRA, 401(k), 403(b), or other qualified retirement plan.

#### Life Insurance

Name Indian River Lakes Conservancy as the beneficiary, or as both the beneficiary and owner, of a new or existing policy.

#### **Gifts of Appreciated Securities**

Gifts of securities, including stocks and bonds, may provide you with savings on capital gains taxes as well as an income tax deduction.

#### **Retained Life Estates**

Through a retained life estate, you may transfer ownership of your home, farm, or other property to Indian River Lakes Conservancy, while retaining the right to live there during your lifetime. This has income tax benefits and can simplify estate settlement and taxes.

#### Charitable Remainder Trust

A charitable remainder trust is a taxexempt irrevocable trust designed to reduce your individual taxable income. It first disperses income to the beneficiaries of the trust for a specified period of time and then donates the remainder of the trust to the designated charity.

#### Gift of Real Estate/Other Assets

Gifts of any type of asset may be made during your lifetime or through your will to provide you with tax benefits.

Land with important conservation values can be donated to IRLC. Houses, buildings, and other developed real estate can be donated as trade properties: the sale of the property then provides funding for conservation projects.
